Raised awareness about literacy and foundational learning, i.e., by promoting and hosting events in the community that focus on literacy and essential skills. Assessed community needs, and developed programs and services in response to those needs. Reduced barriers for learners to access programs and services, i.e., by providing childcare and/or transportation. Fostered community-based partnerships to strengthen adult literacy and foundational learning opportunities.
